





















Newsletter: September 2017 UNDP/UNSOM Integrated Electoral Support Group (IESG) to the Federal Republic of Somalia

Highlights

- On 1 September, the National Independent Electoral Commission of Somalia (NIEC) became a member of the Association of the World Election Bodies (A-WEB) during its third general assembly held in Bucharest, Romania.
- On 10 September, the NIEC initiated a Voter Registration Feasibility Study to examine in detail all aspects related to the introduction of a voter registration system for Somalia in preparation of universal elections.
- On 20 September, the NIEC convened a donor coordination meeting with international partners, presenting the details of its five-year strategic plan (2017-2021) including an overall budget to plan and conduct universal elections in 2020.
- On 27 September, the Ministry of Interior, Federal Affairs and Reconciliation (MoIFAR) and the Ministry of Constitutional Affairs (MoCA) led the first meeting of the Pillar Working Group 1 on Inclusive Politics as part of the implementation of the National Development Plan.
- On 28 September, the NIEC launched the temporary registration process of political parties. With about 20 political associations in attendance, the NIEC presented the required forms and explained the process that will allow political party associations to become registered parties, in line with the political party law adopted in 2016.

Political-electoral updates

On 27 September, MOIFAR and MOCA led the first meeting of the Pillar Working Group 1 (PWG1) on Inclusive Politics, co-chaired by the UE and Switzerland. The P1WG brings together representatives from: The Federal Government of Somalia, FMS, relevant Parliament Committees (OC), relevant national independent commissions, civil society organizations, UN, bilateral donors, implementing partners and International Financial Institutions (IFIs).

The priorities of the P1WG include: 1) advance inclusive political dialogue to clarify and settle relations between the Federal Government and Federal Members States (FMS) and initiate a process of political and social reconciliation to restore trust between communities; 2) To set foundations for durable peace, stability and end the violent conflict that has caused unnecessary loss of lives and human displacement; 3) Finalize and adopt a Federal Constitution by 2019; 4) Prepare for and hold credible elections by 2020/21. The first meeting provided an update, including from MOIFAR and the NIEC

on electoral issues, while discussion was focused on the terms of reference of Pillar Working Group-1.

IESG support to NIEC - drafting process electoral legislation

a. Voter Registration Feasibility Study

Launched on 10 September 2017, the NIEC is currently conducting a voter registration feasibility study together with IESG (UNSOM & UNDP) and BUILD (US funded electoral project from Creative Associates). The aim of this joint study is to examine in detail all aspects related to the introduction of a voter registration system for Somalia, in preparation of universal elections. The study will be assessing the feasibility of voter registration options and methodologies in the specific context of Somalia.

The joined team has been seeking inputs and guidance from key government partners of the Federal Government of Somalia (FGS) and the Federal Member States (FMS), as well as different stakeholders including civil society. The first meetings were organized in Mogadishu with the members of the Federal Government, which was attended by the Deputy Vice Prime Minister, the Minister of Interior, Federal Affairs and Reconciliation, the Minister of Planning, the Minister of Constitution, and Minister of security, the Speakers of the House of the People and the Upper House, the Director of Immigration, different Political Party Associations and civil society.

After these meetings in Mogadishu, the team conducted in September also field trips to the following regions Puntland (Garowe), and Jubaland (Kismayo) and South West (Baidoa), in order to expand the study and seek inputs from the Federal Member States. The team also met in Mogadishu representatives from Hirshabelle and Benadir.

The team is currently compiling all feedback and further internal discussions are being held. A final report is expected next month. Preliminary feedback from various stakeholders relate to the issues of accessibility (including security), the wider electoral legal framework, and the need of a political agreement on crucial constitutional issues. The citizenship law will be an important piece of legislation to define eligible voters. Other issues raised relate to the IDPs, nomadic population and the unknown size of the total population.

b. NIEC's Launch of the temporary Political Party Registration

On 28 September, the NIEC launched the Temporary Registration process of Political Parties with about 20 political associations in attendance. The NIEC presented the required forms and explained the process that will allow political party associations to become registered parties, in line with the political party law adopted on June 2016. The main objective of this ceremony was to show that NIEC is ready to accommodate the temporary registration process of political parties, and to inform the public and specifically political associations to come forward and register as a political party.

c. NIEC coordination meeting with international partners

On 20 September, the NIEC presented to international partners its five-year strategic plan and budget from 2017-2021 to plan and conduct universal elections.

On 31 August, supported by IESG, the Deputy Chair of the National Independent Electoral Commission (NIEC), Mr. Sayed Ali Mohamed, attended the third general assembly of the Association of the World Election Bodies (A-WEB), held in Bucharest, Romania. During the session, the request for membership presented earlier in 2017 by the NIEC was accepted, along with the ones from Papua New Guinea, Colombia and Peru: the new members will join the existing 106 members. The Organization for the Arab Electoral Management Bodies (Arab EMBs) also became an associate member of the AWEB. The NIEC, also member of the Arab EMBs since 2016,

intends to capitalize on the electoral experience and knowledge of these international institutions.

e. Electoral Systems Workshop

From 21 to 24 September, the NIEC organized a technical workshop on electoral systems, facilitated by two international experts contracted by the USAID funded electoral project (BUILD). The workshop at the NIEC was attended by ministry representatives and government officials that have direct relations to electoral framework including the Ministry of Interior and Federal Affairs, Ministry of Women and Human Rights, Ministry of Justice, Ministry of Constitution and representatives from the office of the President and office of the Prime minister. The workshop is in line with earlier technical sessions provided by IESG on electoral systems to representatives for NIEC and MOFAIR, and builds on the formation of an electoral coordination task force amongst members of the FGS that was formed in August under the auspices of MOIFAR.

Upcoming Activities

- 1-10 October: NIEC internal strategic management implementation workshop, which IESG is supporting.
- 4 October: IESG-NIEC-MOIFAR Board meeting: Presentation of Q4/2017 plan with request for donor funding, and circulation of draft IESG Project plan for 2018.
- Late October: NIEC intends to conduct three by-elections (Jubaland, Hirshabelle, Somalilanders community)
